VILLAGE OF WINDSOR, NEW WINDSOR, IL  
AN ORDINANCE TO CONTROL BURNING  
WITHIN THE VILLAGE LIMITS.

THE VILLAGE OF WINDSOR, NEW WINDSOR,  
ILLINOIS HAS PASSED AN ORDINANCE TO  
CONTROL THE BURNING OF BRUSH, TRASH,  
PAPERS, RUBBISH, LEAVES, GARBAGE AND  
OTHER ORGANIC MATERIAL WITHIN THE  
VILLAGE LIMITS OF THE VILLAGE OF  
WINDSOR, NEW WINDSOR, ILLINOIS. THE  
PURPOSE OF THIS ORDINANCE IS TO  
IMPROVE THE HEALTH, SAFETY AND  
GENERAL WELFARE OF THE CITIZENS OF  
NEW WINDSOR.

NO PERSON SHALL PLACE, DEPOSIT, THROW, OR CAUSE TO BE PLACED, DEPOSITED, OR THROWN ON ANY STREET, ALLEY, OR PUBLIC PLACE IN THE VILLAGE ANY ASHES, PAPER, RAGS, STICKS, BLOCKS, POSTER BOARDS, LUMBER, BUILDING MATERIAL OF ANY KIND OR ANY SHAVINGS, DIRT, TIN CANS, JUNK OR ANY RUBBISH OF ANY KIND OR DESCRIPTION. THE APPLICABLE STATE REGULATIONS SHALL GOVERN THE REMOVAL AND DISPOSAL OF ALL HAZARDOUS WASTE.

NO BURNING OF ANY KIND SHALL BE ALLOWED WITHIN THE LIMITS OF THE VILLAGE EXCEPT AS HEREAFTER EXPRESSLY PERMITTED HEREIN: SO LONG AS NOT PROHIBITED BY THE VILLAGE POLICE OR

FIRE CHIEF, THE BURNING OF LEAVES AND YARD MATERIALS SHALL BE PERMITTED BY RESIDENTS OF THE VILLAGE BETWEEN THE HOURS OF 8:00 A.M. AND 8:00 P.M. SO LONG AS SUCH BURNING IS ATTENDED TO BY AN ADULT AT ALL TIMES. LEAF BURNING SHALL BE DONE SO AS NOT TO CAUSE DAMAGE TO ANY STREET OR AVENUE OR TO ENDANGER ANY PERSON OR PROPERTY.

THE BURNING OF ANY STRUCTURE, WHETHER STANDING OR NOT, SHALL BE PERMITTED ONLY AFTER A PERMIT IS OBTAINED FROM THE FIRE CHIEF, WHICH SETS FORTH THE TIME AND PLACE OF BURNING. A FIRE FOR THE PREPARATION OF FOOD FOR HUMAN CONSUMPTION SHALL BE PERMITTED AT ANY TIME AS

LONG AS SUCH FIRE IS ATTENDED TO AT ALL TIMES.

THE FIRE CHIEF OR POLICE CHIEF OF NEW WINDSOR OR THEIR DULY APPOINTED DELEGATE MAY PROHIBIT BURNING OF ANY TYPE WHATSOEVER AT SUCH TIMES AS IT IS DETERMINED THAT SUCH BURNING WOULD BE INJURIOUS TO THE HEALTH OF THE CITIZENS OF THE VILLAGE.

PENALTY: NOT LESS THAN \$100 NOR MORE THAN \$500 FOR ANY ONE OFFENSE. EACH AND EVERY DAY DURING OR ON WHICH A VIOLATION OCCURS OR CONTINUES SHALL BE DEEMED TO BE A SEPARATE OFFENSE.
